

Nix Library/Carrollton Area Network (CAN) Photo Contest

Rules and Entry Information

(Sign and submit this form – one form per photographer)

- > Deadline for submission: Photo submissions can be emailed/sent in starting 12:01 pm March 1, 2016 through 11:59 pm April 9, 2016.
- > Judging: There will be 1 “Best in Show” (1 winner) and 5 “First Place, Second Place, and Third Place” winners in each of the five categories (16 winners). Judging will be done by a panel of Carrollton residents and professional photographers. The winners will be notified via the email address provided at the time of entry.
- > Eligibility: Open to all amateur photographers who are at least 18 years old or under 18 years of age with the consent of their parent or legal guardian.
- > The Carrollton neighborhood of New Orleans is defined as the area from I-10 to Leak Ave. and Calhoun St. to Monticello Ave.
- > How to Enter:
 - Email Photo Contest Entry Form, a Model Release Form for each identifiable individual in a submitted photo, and a Parent/Guardian Release (for photographers under age 18), along with photographs, to photocontest@carrolltonareanetwork.org, by 5 p.m. on April 9, 2016.
 - Mail, or hand deliver Photo Contest Entry Form, a Model Release Form for each identifiable individual in a submitted photo, and a Parent/Guardian Release (for photographers under age 18), along with a CD-ROM containing photographs, to: Photo Contest, Nix Library/Carrollton Area Network, 8026 Cohn St. #1, New Orleans, LA, 70118. Discs and appropriate forms must be received before 5pm on April 9, 2016.
- > By entering/participating in this promotion/contest, you indicate your full agreement to and acceptance of these official rules, terms and conditions and CAN’s decisions, which are final and binding.
- > Model Releases: You are responsible for obtaining the necessary releases from every identifiable person depicted in your photo (for minors, releases from their parents or legal guardians are required), and you must be able to provide copies of those releases to Nix Library/CAN at the time of photo entry.
- > Warranty: You represent and warrant that the photo submission is your original work, that your submission does not violate any agreement between you and a third party, and your photo and its submission shall not infringe upon or violate any law, agreement or other rights of any kind, of any third party, without limitation, rights affecting copyright, patent, trademark, unfair competition, contract, defamation, privacy or publicity.
- > License and Intellectual Property: The copyright in any submission shall remain the property of the entrant and, by submitting a photo, you grant Nix Library/CAN, and those authorized by Nix Library/CAN, a royalty-free, worldwide, perpetual, irrevocable and non-exclusive license to display, distribute, reproduce and create derivative works of the entries, in whole or in part, in any media now existing or subsequently developed, to support its work and cooperating nonprofit partners. Uses include, but are not limited to: print and digital, electronic newsletters; websites, slide shows, and promotional items such as printed cards, and calendars. Any photo reproduced may or may not include a photographer credit. Nix Library/CAN will not be required to pay any additional consideration or seek any additional approval in connection with the above.
- > Release and Limitation of Liability: By submitting a photo, you agree to release, discharge, and hold harmless Nix Library/CAN and its members, officers, directors, and representatives from any claims, losses, and damages arising out of their participation in this photo contest or any contest-related activities.
